I know the economy continues to be the topic of greatest concern particularly in rural communities such as Perth—Wellington. I was disappointed that the recent Federal Budget failed to address the important issues facing smaller communities such as the lack of attainable and affordable housing. This is particularly true for rural communities like ours where the resources needed to address this crisis often do not exist.

Our farmers and the agriculture sector were largely ignored in the recent budget. Whether it is the tariffs on fertilizer, the proposed reductions in fertilizer use, or the ongoing added costs of the carbon tax, Canadian farmers are being penalized and placed at a disadvantage by their own government.

I will continue to work with my colleagues on both sides of the House of Commons to address these issues and will always act in the best interest of the people of Perth—Wellington.
